

NEW ERASMUS+ PROJECT: KATCH_e | JANUARY

- The newly launched ERASMUS+ project KATCH_e addresses the challenge of reinforcing the skills and competences in the field of product-service development for the circular economy and sustainability in the construction and furniture sectors.
- KATCH_e is a knowledge alliance bringing together partners from four EU countries that cooperate in the development and testing of an innovative, problem-based multidisciplinary course, a MOOC as well as product-service development tools for circular economy and sustainability.
- KATCH_e is a 3-year EU funded project that was launched in January 2017 and is part of the ERASMUS+ programme of Knowledge Alliances. This key action is aimed at strengthening Europe's innovation capacity and at fostering innovation in higher education and business.
- Relevant target groups are the universities, including students, professors and researchers; the business community, including companies and business organizations; and knowledge centres, including consultants and technological centres.

KICK-OFF MEETING OF THE KATCH_E PROJECT IN LISBON | JANUARY

- On January 23rd and 24th, 2017, the coordinator of the consortium, LNEG- Laboratório Nacional de Energia e Geologia, hosted the KATCH_e kick-off meeting on its premises. Beneficiaries from Higher Education, companies and research centres discussed how the project objectives could be achieved and laid the foundations of the project. During the next few months, the project will carry out an analysis of training needs and will establish a stakeholders' network to support the transfer of knowledge and help secure the activities after the funded period.
- The consortium seeks to make KATCH_e an important reference on closing the loop providing innovative and multidisciplinary training materials, curricula and tools. The project will indeed reinforce the competences of students and professionals of the target sectors in the field and will strengthen their relationship, increasing the possibilities of employability and contributing to the innovation and competitiveness of the sectors in the framework of circular economy and facilitating its transition to the business world.

CIRCULAR ECONOMY: ONE YEAR AFTER ADOPTION, WORKING TOGETHER FOR THE FUTURE | FEBRUARY

- In late 2015, the European Commission published its Circular Economy Action Plan, along with a proposed review of the current waste legislation. The European Economic and Social Committee (EESC) supports an ambitious implementation of this Action Plan, which includes in particular an indepth consultation of stakeholders and civil society. In previous opinions concerning the circular economy adopted in December 2014 and April 2016, the EESC made the case for a European Circular Economy Stakeholder Platform, whose aim would be to facilitate civil society consultation, cooperation between national, regional and sectoral networks and the exchange of expertise, information and best practices.
- With a view to taking stock of the Action Plan's implementation, looking at next steps and discussing the goals and practicalities of a European Circular Economy Stakeholder Platform, the EESC and the European Commission co-organise a conference which will take place on 9-10 March in Brussels.
